CONDITIONS:

In consideration of the required equipment being provided for the use and enjoyment of the above named skier for the above noted duration of time, I agree to the following conditions:

- 1. I understand that any equipment rented for any particular time, but not returned on time will be subject to a surcharge equal to one half that already paid, and I alone will be responsible for this.
- I agree that if for any reason whatsoever all equipment itemized is not, or can not be returned to the shop on the date which it is due, I will pay to
 provincial parks the full retail value of the said equipment.
- 3. I understand and agree that if I fail to comply with condition #2 (above) before closing time of the park on the date the said equipment is due for return, that the said equipment should be presumed stolen and reported immediately to the R.C.M.P.

Warnings and releases

- 1. I understand that there are inherent and other risks involved in the sport of snow skiing, snowboarding, tubing and fatbiking and I freely accept those risks.
- 2. I understand that injuries are a common and ordinary occurrence in the sport of snow skiing, snowboarding, tubing and fatbiking.
- 3. I understand that a "skier's responsibility code" has been approved by the canadian ski patrol system and that adherence to this code while participating in the sport of snow skiing could reduce the likelihood of injury to myself and others. I verify that I have received satisfactory answers to all my questions regarding this code.
- 4. I verify that I have received satisfactory answers to all my questions regarding the use and function of my equipment.
- 5. I verify that I have provided complete information in regard to the height, age and weight of the person using this equipment.
- 6. I verify that the visual indicators on my bindings correspond to the d.i.n. settings as shown on this rental agreement.
- 7. In consideration of the fee and the rental to me of the above equipment by the Mark Arendez Provincial Ski Park at Brookvale, it's servants, agents and other authorized personnel (hereinafter referred to as "the park"), I agree to save harmless and keep indemnified the park from and against all claims, actions, costs, expenses, demands and liability in respect to death, injury, loss or damage to my person or property or to any other person or property, howsoever caused, arising out of or in connection with the rental and usage of the equipment itemized above and notwithstanding that the same may have been contributed to or occasioned by negligence, or the installation on the part of the park. I accept myself, the full responsibility for any and all such damage, injury, loss or death which may result. It is understood that the agreement is to be binding on myself, my heirs, executors and assigns.
